

## Recovering Income Tax for Christchurch

It will be of great financial benefit to Christchurch if you would complete this Gift Aid Declaration. At present rates it will enable us to claim an additional 25p from HM Revenue & Customs (HMRC) for every £1 you give to the Church.

If you would like to give by standing order through your bank or building society, the Gift Aid Secretary or Treasurer will give you the details that you need.

You may also give by cheque or the Digital Card Reader in the vestibule.

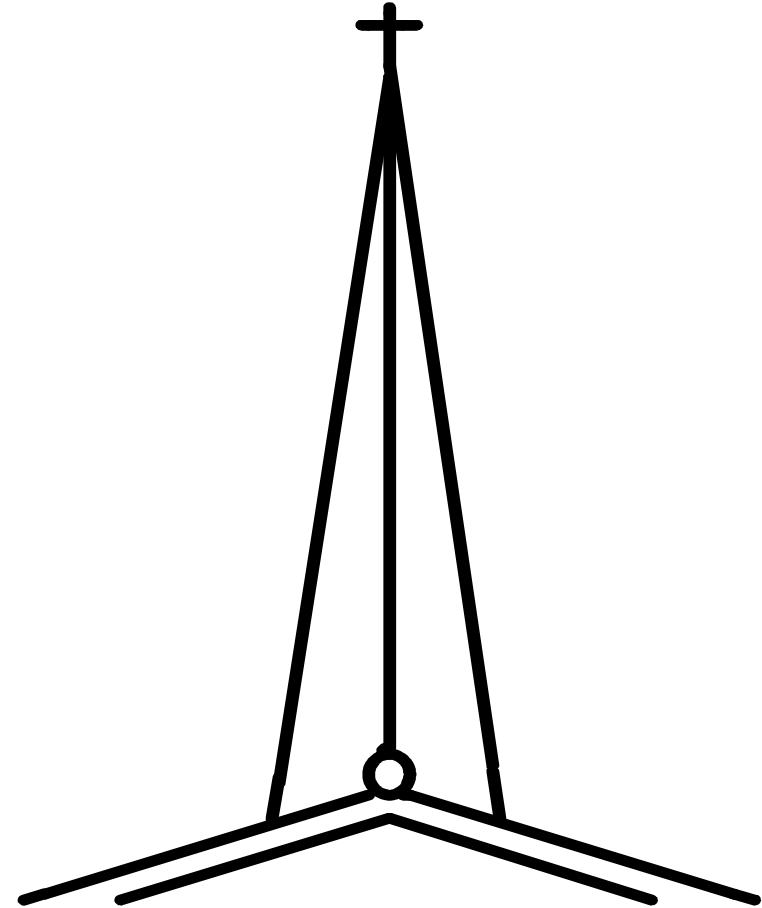
If you pay income tax at the higher or additional rate, you may claim tax relief on your self assessment tax return or by asking HMRC to adjust your PAYE code.
